KAB was effectively reclassified under Bursa Malaysia's newly introduced Renewable Energy Sub-sector within the Energy and Utilities sector on 13 January 2025. The milestone was announced at the Renewable Energy Sub-sector Launching Event following Bursa Malaysia's 8 January 2025 announcement.

The event highlighted Malaysia's ambitious goal of achieving 70% renewable energy capacity by 2050. Mr. Leong See Meng, Director of Origination & Listing at Bursa Malaysia, emphasised the role of the private sector in driving this vision forward. 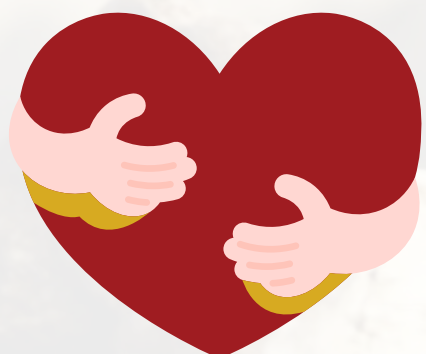
