KEJURUTERAAN ASASTERA ENTERS INTO SOLAR PV ENERGY BUSINESS WITH 80% SUBSCRIPTION IN MAYANG HIJAU

KUALA LUMPUR, 16 February 2021 – Kejuruteraan Asastera Berhad ("KAB" or the "Company"), an electrical and mechanical engineering services provider in Malaysia, through its wholly-owned subsidiary, KAB Smart Solar Energy Sdn Bhd ("KSSE") has today entered into a Binding Term Sheet ("Term Sheet") with Mayang Hijau Sdn Bhd ("MHSB"), Evergreen Thumbsup Sdn Bhd ("ETSB") and Mr Heng Boon Liang ("HBL").

In accordance with the Term Sheet, KSSE will subscribe 800,000 ordinary shares in MHSB, representing 80% of MHSB's proposed enlarged paid up share capital, for a cash consideration of RM800,000. ETSB will in turn subscribe for 199,999 shares for RM199,999. HBL shall transfer his one ordinary share, equivalent to RM1 in MHSB in favour of ETSB. Upon the completion of the proposed subscription, MHSB will become an 80% owned indirect subsidiary of KAB, and the remaining 20% will be held by ETSB.

Meanwhile, MHSB has recently entered into a Solar Supply Agreement to finance, design, construct, own and operate a 1.58-megawatt peak solar photovoltaic ("PV") energy generating system under the build-operate-transfer (BOT) concept, with the expected commercial operation date by the third quarter of 2021. Additionally, MHSB is in the final stage of negotiations to secure a cumulative capacity of 10-megawatt peak of contracts. Under these contracts, MHSB is predominantly responsible to operate and maintain the solar PV system for a concession period of twenty-five (25) years, and upon the expiry of the concession period, the ownership of the solar panels installed will be handed over to the customers.

"The proposed subscription into MHSB is part of our plans to further strengthen KAB's position in the energy market. We are confident that this proposed subscription will enhance our recurring income stream from the Company's existing core businesses and subsequently create more value for all our
