# **Kinergy Advancement's Potential Entry Into Being An Independent Power Producer (IPP)**



On **7 February 2025**, Kinergy Advancement Berhad ("KAB") announced the **acquisition of a 47.5% equity stake in Jati Cakerawala Sdn Bhd** ("Jati Cakerawala").

This acquisition marks KAB's potential entry into being an Independent Power Producer (IPP).

#### At Least 650-Megawatt Capacity Gas Turbine Power Plant to be repowered.

The plant was decommissioned in March 2024 after completing its 21-year power purchase agreement (PPA).

Having been a critical asset in the nation's energy supply for over two decades, the site has now reopened as a high-potential project. The existing energy infrastructure is expected to deliver significant benefits and play a pivotal role in the success of this repowering project, further underscoring the value of this acquisition.

Going in line with KAB's sustainable energy vision, its redevelopment and repowering is expected to further



strengthen the nation's energy infrastructure and offer longer-term energy security for Malaysia's future growth.
