KAB'S CUMULATIVE NINE MONTHS REVENUE RISES BY 20.1%

KUALA LUMPUR, 26 November 2021 – Kejuruteraan Asastera Berhad ("KAB" or the "Group"), an electrical and mechanical engineering services provider in Malaysia, is pleased to announce its third quarter results for the financial year ending 31 December 2021 ("Q3FY2021").

For Q3FY2021, KAB generated a profit before tax ("PBT") of RM0.8 million on the back of a revenue of RM32.0 million. For the cumulative nine-month period, revenue was RM121.9 million, up by 20.1% as compared to RM101.5 million a year earlier. PBT improved by 11.4% to RM4.9 million from the RM4.4 million in the corresponding period last year.

Commenting on the results, KAB managing director Dato' Lai Keng Onn said, "We will continue to expand our profitability as we are hopeful that our economy is now on the road to recovery with the reopening of the economic and social sectors since August this year. Our business strategies remain intact to grow our green energy solutions division and widen our footprint into the neighbouring ASEAN countries. Our announcement last week on the three new solar projects in Thailand is testament to our business plans. We now have an aggregate installed capacity of 16,071 kilowatt-peak, with Thailand accounting for 8,449 kilowatt-peak of this total capacity. Moving forward, we are committed to deliver sustainable growth by exploring value accretive opportunities in the energy sector, as well as replenishing our M&E order book. Our mechanical and electrical engineering division has outstanding order book of RM358 million as at 30 September 2021.
